The Medical Practice Act

- Renewal (annually)
- Complete & <u>accurate</u> renewal application: series of questions (only previous year)
- Compliance with CME (60 hours in previous 3 years)
- Occupience with Medical Treatment Act & Pain Management
 - one hour each year Pain Management or Addiction Medicine
- Output the Oklahoma Tax Commission

No grace period for renewal

- Due on or before (60 days) the 1st of the renewal month
- 2nd day the license is placed inactive (can not practice)
- Within the next 60 days license can be activated w/a late fee
- After 60 days, the license is suspended reinstated by board

The State Medical Board Complaint Process

Board staff * determination to close or open investigation.
 * Board Secretary, Director, Dep Dir. Legal & Investigative staff

Investigation to gather facts, records, depositions, witness interviews, etc.

 <u>Board staff</u> determination to <u>close</u>, <u>issue</u> a "Letter of Concern" <u>or</u> <u>file</u> a formal Complaint & Citation.



Complaint Process (cont'd)

- <u>Board staff</u> available to meet with the doctor and/or lawyer about the complaint.
- From the above meeting, determination to present a settlement agreement "Voluntary Submittal to Jurisdiction" (VSJ)* to the Board or schedule a full hearing with the Board. *(All VSJ's must be accepted, modified, or rejected by the full Board)
- Medical Board Hearing to determine disposition.
- Case could be dismissed



The Medical Practice Act – LAW & RULES

• Composition and duties of the Board

- 11 members: 7 MDs & 4 public members
 - Appointed by the Governor
 - 7-year terms @ no compensation
- Public members coterminous with Governor
- Final authority on all issues of licensure and discipline
- Board en banc serves as Judge and Jury in all disciplinary hearings.
- Board en banc or by circularization decides on the issuance of all licenses.

 (exception: Board Secretary can issue 1st year training licenses can hold it for Board decision if problem applicant)

• Determines Board policy, rules, and law.



The Oklahoma Medical Board

Board Meetings are held 7 times a year (every other month starting January with a special applications meeting in June). (Open Meetings)

> Board Meetings are scheduled for three days*. (Thursday, Friday, and Saturday) (exception: June is one-day)

Appeal process: Oklahoma Supreme Court

• Top categories:

- Substance abuse
- Prescribing issues
- Quality of Care



Volume of Complaints (not formal citations)

Receive approximately 700 - 800 per year Attitude of physician & office staff Substance Abuse and/or Use*

Physicians Treating Self or Family

Unprofessional Conduct

"Prescribing, selling, administering, distributing, ordering, or giving any drug legally classified as a <u>controlled substance or recognized as an</u> <u>addictive dangerous drug</u> to a family member or to himself or herself...except outside the second degree of consanguinity (Blood Relative) or affinity (Marriage)...or medical emergency"



Caution for treating family and relatives

Lack of true doctor/patient relationship Lack of appropriate physical examination Lack of appropriate testing Lack of medical chart Lack of medical objectivity
