

GRANT & GLUECK MEN

Our sample consists of two unique groups of men recruited in the 1930's and 1940's:

1. Harvard Cohort - Grant Study

The participants for this study were chosen when they were around 19 years old. It is a group of 268 Caucasian men from the Harvard classes of 1939-1944.

2. Boston Cohort - Glueck Study

456 Caucasian men from the neighborhoods of Boston were selected at ages between 11-16 by Harvard Law School professors Sheldon and Eleanor Glueck.





The “Drivers” of Malpractice Cases

In a study of plaintiff depositions for malpractice lawsuits that were settled against a large metropolitan medical center, researchers found that, in general, **patients and families decided to litigate because they perceived their doctors did not care.**

They said that doctors were ***unavailable, discounted their concerns, communicated poorly, or just failed to understand*** the patient’s or family’s perspective. It wasn’t the technical part of the medical care; it was the *caring* part of the medical care.


